







# VISITATION HOMES IS A PERMANENT SUPPORTING HOUSING PROGRAM OF CATHOLIC SOCIAL SERVICES LOCATED IN KENSINGTON.

They serve families experiencing homelessness who are referred from the Office of Homeless Services. Visitation Homes help families overcome the trauma that led them to the program. Residents are connected with educational, financial, substance abuse, and mental health counseling.

#### Giving Hope to Families

"Last year, during the pandemic, I was evicted from my family home. I was distraught and had nowhere and no one to turn to. I found a shelter where I could stay, but they didn't allow children there and I had to leave my son with his father. The shelter was rough and very scary. I had to adapt to survive such a tough environment. My life changed with one phone call. I was accepted into Visitation Homes, part of Catholic Social Services, in Kensington. God was truly answering my prayers. I qualified for a two-bedroom apartment and everything I needed was supplied by Visitation Homes. The women here come from domestic violence backgrounds, and I was suffering from bipolar disorder, anxiety, and PTSD. They gave me an environment to heal from the abuse I had suffered. I needed to find something I was passionate about, something to help me heal from my pain, so I enrolled in Community College, studying psychology. I wanted to emulate what I had at Visitation, pay it forward and help others the way the Case Managers here have helped me. Having my own apartment has made me feel independent and normal again. Being homeless is depressing - being in a situation where you can't provide for yourself and don't have privacy makes you feel forgotten. Visitation Homes changed my life. I now have dignity and pride; it is an honor to live here. Visitation is home. When you support the Catholic Charities Appeal, you are helping families in need get through some of the hardest times in their lives. #### Giving Hope to a Struggling Community

"During the pandemic, I found myself unemployed and in need of food. I had never struggled like this before; I have an Art and Business Degree and never knew what it was like to feel hungry. One cold day I was walking the streets in my community, Kensington, in search of a hot cup of coffee. I stumbled upon the Community Center at Visitation, and my life completely changed. They took me in, served me coffee and a meal. I lived in this neighborhood for 15 years and didn't know they existed. I kept coming back each day, and they offered me a job working in maintenance. I wanted to be part of this community and help people in need, as the food pantry helped me when I was in need. People in this area are struggling. They need food to survive, and the food pantry at the Community Center helps so many people who have nowhere else to turn. Kensington is a rough neighborhood, and most people in this area live below the poverty line and cannot afford the high food prices. We are deeply in need in Kensington, and without help from the Catholic Charities Appeal, we will not be able to survive. Just a little bit can make a great difference to this community. They receive 24/7 nursing care and Direct Care Support. We have a Behavioral Specialist; we offer Art and Music Therapy and so many different activities. # LOCAL MISSION ACTITIVITES & CLERGY





#### Giving Hope to Special Needs Children

"My husband and I were lost. My son, Dylan, had some developmental delays, and we weren't sure what school we could send him to. My older son, Matthew, attended St. Lucy School for Children with Visual Impairments, and I knew I wanted a similar school for Dylan. I wanted an environment of love, respect, and acceptance. The principal at the time suggested Saint Katherine School, and it has been a perfect fit! Dylan is now 19 years old and has been at Saint Katherine since he was 7. He is currently enrolled in the program at Archbishop John Carroll High School. You don't just find a school for a child with special needs, you find a home, which is what we found at Saint Katherine. Dylan feels safe here, has friends, and is receiving a quality Catholic education. We are so fortunate in the Archdiocese of Philadelphia to have three schools of Special Education. It is so important to find a place where the kids can fit in and be part of the community. We have four children, and we wanted a Catholic school education for all of them, and that has been a struggle. Without the help of the Catholic Charities Appeal, I don't know if we would be here. Please support the Appeal because children with special needs are depending on your help and generosity. KATHERINE DAY SCHOOL STRIVES TO MEET THE UNIQUE NEEDS OF A DIVERSE STUDENT POPULATION. THEY ARE THE ONLY ARCHDIOCESAN SCHOOL THAT PROVIDES A SCHOOL PROGRAM FOR STUDENTS WITH MULTIPLE IMPAIRMENTS.

#### Giving Hope to Students

"My first semester of college was spent at home in Maryland taking online classes due to the COVID-19 pandemic. This year, I was thrilled to be living on campus surrounded by my fellow university students. At first, it was a culture shock being on campus with so many individuals who did not share my Catholic values. That all changed when I found the Penn/Drexel Newman Center. The Newman Center is the Catholic student center and community on campus. Students from both schools come here to be with likeminded individuals and to grow in our faith. They offer us so many amazing programs, like bible study, speaker series, daily Mass, weekly adoration, and service projects. I am currently the Chair of the University of Pennsylvania's Leadership Team that works with Drexel University on a service outreach project, "Christ in the City." This is a homeless outreach program that brings practical needs to homeless individuals throughout center city. We interact with them and provide food and material assistance to build that relationship and honor their human dignity. When you have young people who go out into the world, they inspire others to follow in their footsteps. Without funding from the Catholic Charities Appeal, we would not be able to come together to celebrate our faith and partake in the activities the Newman Center provides.
